1. Introduction

HEROES is a H2020 project that started in December 2021.

The HEROES project's main objective is to use technology to improve the way in which help, and support can be provided to victims of Trafficking in Human Beings (THB) and Child Sexual Abuse and Exploitation (CSA/CSE). Moreover, the HEROES project will establish new innovative strategies that in the short, medium, and long term will improve the way in which Law Enforcement Agencies (LEAs) and Civil Society Organizations (CSOs) carry out criminal investigations, assist rescued victims, and prevent the occurrence of these crimes. In order to achieve all the objectives and deliver all the deliverables with the expected high-quality and on time, a cooperation between partners while at the same time maintaining a strict control over the progress, risks and achievement, is need. For that, the management structure needs to be defined. Most of the management structure were already envisioned in the Description of the Action (DoA), nonetheless, some of them have been extended or redefined in a more detailed manner in the following section.



2. Management of the HEROES Project

2.1. Management Structure




Figure 1: HEROES Management Structure

The structure of the project management is shown in Figure 1. The roles of the different Bodies and people involved will follow the latest DESCA model Consortium Agreement (CA) for H2020, adapted to the Consortium's needs and constraints.

2.3. Steering Board

Steering Board (SB) is chaired by the Project Coordinator, Dr. Luis Javier García Villalba and consisting of the Partners' team leaders, the Steering Board will be responsible for:

- Monitoring of project progresses, achievements and costs.
- Preparation of contract changes (budget, resources, plans, etc.).
- Solution of problems that have a potential impact on project strategies, resources and achievement of planned objectives, definition of the necessary contingency plans.
- Review the declaration of know-how and/or knowledge

Within the Steering Board, conflict resolution will be handled and solved by consensus. Should the consensus not be achievable, a majority vote will be used: each member will hold one vote. He has ample experience in EU projects, having participated in H2020 (RAMSES) and COST calls (CRYPTACUS), in the role of vice-Chair in the latter. He has been involved in assessing proposals for the Commission and other funding bodies, including the FNRS (Belgium) and the ANR (France). He has a technical background in multiple aspects of Computer Security, including Data Hiding (he is a member of EUROPOL's CUING initiative), forensics and IOT (he is a member of the ENISA expert group). He has collaborated with Law Enforcement and Intelligence services across Europe in his work as a forensic expert, particularly on multimedia forensics. He has ample experience handling EU Classified information at some levels, notably during his participation in different international projects such as H2020 RAMSES project, that had several outputs at higher classified security levels.
